Incorporated in 2007, One Globe Foundation's (OGF) launch initiative was an alliance with United Nations World Environment Program in support of World Environment Day.

OGF's belief in leveraging entrepreneurial ventures to solve environmental and social infrastructure problems has led them to create a self-sustaining, integrated development model that is designed to address complex problems through community, construction and capital symbiosis, now called O.A.S.I.S. - Optimized Assets and Sustainable Infrastructure

Solutions. This proven, successful model has been adopted and implemented over the last decade serving over 2 million people, nearly 200 for-profit enterprises, in more than 300 communities and has attracted countless supporters including the Bill and Melinda Gates Foundation.

ISLAND Wai has adopted One Globe's O.A.S.I.S model and are set to launch in Fiji - offering the ISLAND Wai bottling plant as the catalyst project to both investors and philanthropists who are committed to not just raise the tide, but to initiate the sea change that inspires global transformation.

How It Works

The Fiscal Sponsorship Program is a preapproved grant relationship between ISLAND Wai and OGF, where ISLAND Wai has engaged OGF as a fiscal sponsor in an effort to spend more time on mission-related work and fundraising. Contributions to the OGF/ISLAND Wai Sponsorship are designed to provide ISLAND Wai the resources necessary to achieve its outreach efforts by ensuring that the ISLAND Wai bottled water project will become an economic catalyst for social change in the islands of Fiji.

Regarding the long-term sustainability for solutions in local Fijian communities, the ISLAND Wai bottling facility is an integral part of the OGF's model, but the sustaining programs become stand-alone enterprises - an innovative piece of the OGF model that allows its championed projects to not only be selfsustaining, but scalable. By leveraging the success of the "for profit" enterprise and 100% of its net profits focused on community needs, skills, strengths and traditions, ISLAND Wai is
